I, the above named applicant, who is or who desires to be a utility services user in the Kosciusko Water & Light Plant service area, agrees as follows.

1. **Connection and Tap Fees.** To pay a meter connection fee and/or tap fee for service connection, as the case may be, according to the fee schedule of the Kosciusko Water & Light Plant, prior to the date Applicant begins to receive services and agrees they have followed the guidelines set forth by the State Department of Health regarding onsite wastewater disposal.
2. **Rates and Service Charges.** From the date Applicant begins to receive Utility services, to be obligated to pay for all utility services at the rates established by the Kosciusko Water & Light Plant.
3. **Discontinuance of Services.** That should I fail to make payment for utility bills received, the Kosciusko Water and Light Plant may discontinue any and all of my utility services, until such time as all delinquent bills, service charges, and reconnect charges are paid in full. In addition, the Kosciusko Water and Light Plant may disconnect the meter and /or service lines serving the Applicant, as necessary, to effect discontinuation of utility services. Applicant shall pay a minimum reconnect fee of \$30.00 before service is resumed. However, if the meter has been removed, the Applicant shall pay a reinstallation fee of \$100.00 before service is resumed.
4. **Cross Connections.** Not to install any cross connections, and to prevent any backflow of water to the Kosciusko Water & Light Plant's water distribution facilities. The Kosciusko Water & Light Plant has the right to inspect the Applicant's plumbing for cross connections and other public health hazards.
5. **Utility Services Shut Offs.** The Kosciusko Water & Light Plant has the right at any time, without notice, to shut off or curtail utility services in the event of a scarcity, or to repair or maintain the Kosciusko Water and Light Plant's electrical and/or water distribution system.
6. **Guarantee.** If the Applicant is a corporation or partnership, the undersigned individual, signing for the Applicant, personally guarantees payment of all utility services charges, costs, and obligations described in this agreement.
7. **Applicant's Water Service Line.** The Applicant has the obligation to construct, operate, maintain, repair, and replace, at their sole expense, any water service line from the Kosciusko Water & Light Plant's water meter to the Applicant's property.
8. **Onsite Wastewater Disposal.** The applicant agrees that they have followed the guidelines set forth by the State Department of Health regarding onsite wastewater disposal.
